The following statement of refusal of the hepatitis B vaccine must be signed by an employee who: Chooses not to accept the vaccine. Unfortunately, some parents will refuse to have their child receive some vaccines. A survey of children six months to six years of age reported that 15% of parents followed an alternative vaccination schedule. Provide parents with the appropriate Vaccine Information Statement (VIS) for each vaccine at each immunization visit and answer their questions. Keep the form in Documenting Parental Refusal to Have Their Children Vaccinated. This is not an immunization waiver form. 7 I understand that my refusal to have my child vaccinated does not exempt my child from Georgia school or child care facility immunization requirements and that he/she will be unable to attend school or child care without the required vaccinations immunized child. This document must be completed before a provider can sign a Certificate of Exemption from childcare, preschool, school, or college immunization.
